Conditions

A. Exhibitors, employees and other representatives will comply with all general rules and regulations prescribed by the Winnie Area Chamber of Commerce (WACC).

B. All installations erected by the exhibitor shall be subject to the approval of WACC.

C. Exhibitors shall not transfer or sublet the space or any part thereof or permit the same to be used by any other person without the prior written consent of WACC.

D. WACC shall have the right to terminate the contract granted hereunder at any time without liability upon the refund of the fee paid herewith. No refunds, regardless of weather, will be made after February 16, 2018, no exceptions.

E. WACC shall have full access to the space covered by this contract at all times.

F. Exhibitor will keep exhibits open throughout the entire event during the following hours:

Friday, March 2, 2018 - 5:00 pm to 12 Midnight

Saturday, March 3, 2018 - 9:00 am to 12 Midnight

Dismantling of the booth or depletion of exhibits in any way shall not take place before the official end of the event (6:00 pm, Sunday, March 4, 2018) without prior approval of WACC.

G. Exhibitor will indemnify and hold WACC harmless from all costs, losses, damages, or expenses including expense from litigation and attorney's fees resulting from any loss, injury or damage real or asserted, to any person or property arising out of any act or omission of exhibitor or his employees or other representatives. If requested, exhibitor will furnish WACC with evidence that exhibitor has insurance in force with a reputable insurer, including coverage (with limits approved by WACC) against contractually assumed liability. The Winnie Area Chamber of Commerce, its officers, agents, or members, the Winnie Area Communities and the corporate sponsor shall not be held responsible for any loss or damage due to theft, fire, accident or other causes, but will use reasonable care to protect the exhibitor from such loss.

H. The exhibitor will completely set up his booth by 3 pm, Friday, March 2, 2018, and will remove all property and all structures placed on the space by him and will surrender the space in the same condition, except for the natural wear and tear and damage not resulting from this contract, as at the beginning thereof. The area should be cleared by 12 Noon, Monday, March 5, 2018.

I. Security will be provided by WACC, March 2, 2018 through Sunday, March 4, 2018. Exhibitor must be responsible for his own booth during show hours.
